



A Few Points About Numbers And Politics

How Much Does The State Of Iowa Contribute To Nonpublic Schools?

In response to your emails to legislators this session asking the legislature to restore textbook and transportation funding and consider Iowa ACE's Education Savings Account proposal, many of you have received responses with some interesting numbers. At least two different estimates have circulated with numbers dramatically over-stating the dollars Iowa invests in nonpublic schools and in school choice. We want you to have the most accurate numbers we are aware of:

Nonpublic school transportation - \$8.7 million
 Nonpublic textbook services - \$600,000
 State aid for nonpublic shared-time - \$1.1 million
 Area Education Agency (AEA) services ~\$3.5 million
 Tuition and Textbook Tax Credit - ~\$3 million
 School Tuition Organization Tax Credit - ~\$11 million
 Other support - \$135,000

Total Aid For Nonpublic Schools: ~\$28 million

Tax credits can be considered as revenue foregone by the state and not direct appropriations (the State isn't writing a check). The only direct appropriation of funds we know of is, in some cases, transportation services. All other appropriations are made to the public school district or AEA which then shares services with the nonpublic schools in its area. Textbook funding is currently limited to only \$20 per student. Therefore, these numbers are accurate but only a small portion of these dollars are direct aid to

nonpublic schools and not every school participates in every program.

Keep in mind that regular state aid for public K-12 schools is almost \$3 billion! Even if you assumed the highest possible cost for the proposed Education Savings Account (ESA) legislation and kept everything else intact, we could see universal school choice in Iowa for a tiny fraction of what we currently spend on K-12 education in Iowa! **School choice is the most cost-effective education reform!**

Textbooks & Transportation Funding

Many of you have responded to our [action alert](#) and emailed your Representative and Senator asking that they restore these funds to the levels before back-to-back budget cuts a number of years ago. Although most programs have seen these dollars restored, we are having a difficult time getting the legislature to restore these funds. Some of you have asked us why.

The simple truth is that there are two main groups of legislators at the Capitol: one that only increases spending on a few of its top priorities for the year and one that finds it difficult, philosophically, to level the playing field for private education options. This leaves very few legislators willing to work at restoring these funds or fully funding the State's current commitments to nonpublic school families. We are extremely grateful to those few legislators who work each year to rectify this and encourage you use our [action alert](#) if you have not already done so. We'll update you on the final result of our efforts after the session's end!

ESA Legislation Update

We had two goals this year: work with Iowa ACE on perfecting our ESA legislation and demonstrate to the Iowa House and Senate that Iowans are behind ESAs. We accomplished both goals. We are proud of the two bills that have been introduced and are grateful for the *thousands* of Iowans who responded to the school choice coalition's call to action and emailed their Representatives. Although we hoped the legislature would act quickly, the bill did not survive the "funnel" deadline during this session.

In the House, Representatives Chris Hagenow, Jake Highfill, and Peter Cownie co-sponsored [HF 2090](#). The bill received a subcommittee but did not advance further.

In the Senate, Senator Behn [introduced](#) a new version of the ESA bill, co-sponsored by *every Republican* in the Senate! We appreciate his support and the willingness of each of the 24 co-sponsors to sign on. We will continue working with [Iowa Advocates for Choice in Education](#) and the Iowa Catholic Conference on this legislation.

ESA Numbers: The Real Story

Many of you have received emails from legislators commenting on the cost of ESAs if this year's bill were to be passed. We want to clarify the context of those numbers so that, moving forward, you are armed with the facts when talking about ESAs and how they would benefit Iowa families.

Some estimate ESAs could cost \$207 million. Although theoretically possible, similar programs implemented in other states demonstrate clearly that not every private school family and a small percentage of public school families will utilize the program, putting the realistic annual cost of the program at a level that is less than last year's ed reform bill on an annual basis and much less than many of the numbers that have been discussed for "allowable growth" in public school budgets this year.

Some claim ESAs would divert money from public schools. There is no mechanism in the bill to divert money from public schools. Public schools will still receive local property taxes, their local option sales tax, and other State revenues regardless of where children attend school. We have not seen any choice program demonstrating negative consequences for public school budgets or (more importantly) student achievement.

The ESA concept is cost effective, true ed reform that respects the role of parents. It is a fraction of the cost public K-12 schools receive (currently around 50% of a \$6.5 billion budget) and will demonstrably increase student achievement for both public and private school students.
